SYNOPSIS:

On June 15th 2024, at approximately 10:15 a.m. Haldimand County OPP received a Domestic Dispute call for service at a McDonald's restaurant located at 282 Argyle St. S., Haldimand County. The complainant Edwin NEWTON, reported that his ex partner Melanie GRILLO were yelling at him and calling him a pedophile in front of other people. Edwin advised there was an ongoing custody battle for his 6 year old daughter Zaria GRILLO-NEWTON. Edwin advised that Melanie,

and Zaria had left the McDonald's approximately 5 minutes prior to the call.

At 11:55 p.m. Police spoke with Edwin via a phone call. Edwin stated that the parties had a Family Court session the day prior and he was granted 1 hour visit with Zaria at a mutual public location, the McDonald's restaurant. Edwin stated that because of the ongoing custody battle he records everything. Edwin stated that during the time he was to have with his Zaria, Melanie had left with her. Edwin then continued to record and follow Melanie to her car. , who was present at the visit followed Edwin outside. Edwin then stated that he and began chirping (verbal dispute) at each other outside. Melanie then came over to Edwin and and joined in the chirping. Edwin stated that Melanie and both called him a pedophile in front of other people. The dispute did not escalate past that point and Melanie, and Zaria left in their car. Edwin also stated that Melanie have created a "gofundme" website (a website used to gather public donations), and on their page he is victim of defamatory comments and slander. Edwin requested that Police charge Melanie with Harassment and Defamatory Libel charges. Police advised there were no grounds to proceed with harassment charges. Edwin was not concerned for his safety nor wanted them spoken to, but was adamant that grounds existed to charge them for Defamatory Libel based on the gofundme website. Police sent an Axon citizen link for Edwin to share his evidence. Edwin accepted victim services and participated in a Domestic Violence Supplementary Report.

At approximately 4:29 p.m. Police made spoke with Melanie at their residence. stated their concern for Edwin to be near Zaria and that it was apparent Zaria is uncomfortable around Edwin. advised that the courts had ordered a 1 hour visit at the McDonald's restaurant, and Melanie was specifically told to walk away from Zaria if Zaria was having difficulty staying with Edwin.

Melanie stated that she tried to leave Zaria at the table with Edwin, excusing herself twice to go to the washroom as instructed though she was instead leaving the restaurant. Zaria followed Melanie out twice and seemed uncomfortable staying with Edwin. Melanie then allowed Zaria to come with her and placed her in the car. stated the Edwin followed Melanie and Zaria outside recording them.

Melanie heard the argument starting and walked over to see what was going on, only to also become involved in the verbal argument. stated they replied to Edwin's comment by calling him a pedophile and then left with Zaria.

At 5:02 p.m. Child and Family Services was notified.

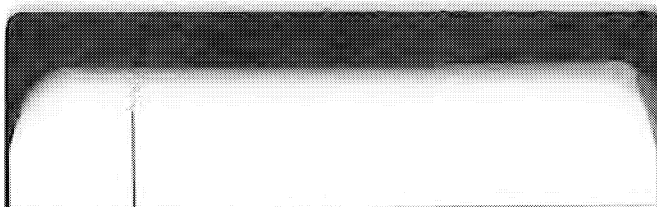

SYNOPSIS:

On Saturday, August 27th, 2023, at 10:25 hrs, Norfolk County OPP were dispatched to a domestic dispute at 34 Somerset Drive in Port Dover. The complainant, Edwin Adams Newton, who prefers to go by Adam, advised that he was calling from outside his residence. He stated that his exgirlfriend, Melanie Grillo, was there in her vehicle with their daughter Zaria Grillo. Adam advised that was supposed to have a 10:00 am, visit with his daughter at his residence. He stated that Melanie would not let Zaria leave with him.

The call taker advised that she could hear Zaria yelling/crying in the background.

Adam stated that Melanie was offering lollipops to make Zaria stay with her. Adam relayed to the call taker that there was a court order stating that Melanie "was to remove daughter from the vehicle and drop her off". Adam stated he went to get his daughter and Melanie pulled Zaria back into the vehicle.

At 10:29 hrs, PC SENCHOWAY and PC ROBERGE arrived on scene. Police observed Adam standing at the end of his driveway calmly. Melanie and Zaria were across the road near her vehicle. |

PC Senchoway spoke with Adam on his property and PC Roberge spoke with Melanie on the far side of her vehicle. PC Roberge observed Zaria sitting in the front passenger seat. She was visibly upset and it appeared as though she had been crying. Melanie advised that today was the first day of a new "temporary" court order. Melanie was supposed to drop Zaria off between 10:00 hrs, and 15:00 hrs, today and depart the residence.

It was observed that Justice MCLAREN signed this court order two days ago. Melanie advised that she had attempted to comply with the court order but Zaria was scared and did not want to go inside her father's residence. Melanie advised that they previously had visits in the park together. Melanie then disclosed to police that Adam had sexually assaulted their daughter in the past (RM22154661). This was previously reported and the result of that investigation was insufficient evidence to proceed. Two physicians concluded that it was diaper rash.

Melanie went on to say that she was very upset that there were no charges laid. She stated that she had already told the police that Zaria had been tied up during a sleep over, had a gummy bear inserted into her anus and then slept in the same bed with Adam while he was naked. Police confirmed that there was insufficient evidence for all of the offences listed.

Police briefly spoke to Zaria. She was again, visibly upset and stated that she did not want to go inside her dad's residence. Police advised that they would not force her to do something she did not wish to do. Police inspected the court order. There were numerous hand written points, however; it was signed by Justice of the Peace. Police did observe the following wording that Melanie was to remove the child from the vehicle and deliver the child to Adam. Police attempted to reason with Zaria but she was firm that she did not wish to have a visit inside his residence today.

Police then spoke with Adam. He expressed his frustration as he wanted to see his daughter. He believed that his ex, Melanie, was playing "games". He stated that he never got alone time with his daughter. He stated that Melanie had recently accused him of "raping" her and stated that was how Zaria was conceived. He stated this was not true and thinks it is a game to get custody. He was very frustrated that he's lost a lot of significant time with his daughter. Adam also disclosed that he felt harassed. She stated that Melanie had started a goFund me and had him listed as a child abuser with a posted CAS letter that was not relevant. He advised that he just wanted to spend time with his daughter without Melanie present as whenever Melanie was around, Zaria would not speak to him and she would cling to Melanie. He advised that Zaria used to have so much fun when she came to his residence and he just wanted to continue his father-daughter bond with Zaria. He advised that this was not possible with Melanie around.

Police attempted to mediate the situation. Police offered to go inside with Zaria at the beginning of her visit to make her feel more comfortable. Zaria once again declined this. She was adamant on not going inside the residence.

At this time, police also provided advice to Adam for his on-going custody battle. He was advised to continue to go through the proper legal channels to obtain custody visits and to continue to meet and attempt to have a visit. Police were able to get both parties to agree to another park visit. Zaria stated that she would be comfortable seeing her dad at the park as long as Melanie was present.

Police observed Zaria to be avoiding Adam at the park. She often stayed within five or so metres of Melanie. Police attempted to have Melanie wait in her vehicle so that Adam could have father-daughter time with Zaria. Melanie began to walk towards her vehicle and Zaria ran after her pleading her not to leave.

At 11:30 hrs, PC Roberge spoke with Sgt. POULTON and provided him with an update.

At around 11:40 hrs, Adam advised that he was going to go back to his home. He stated that there was not much of point to the visit, as he was not getting to talk to his daughter at all and she was actively avoiding him.

The occurrence number was provided to both Adam and Melanie and they were directed to go through the Freedom of Information if they wished to obtain a copy of the police report.

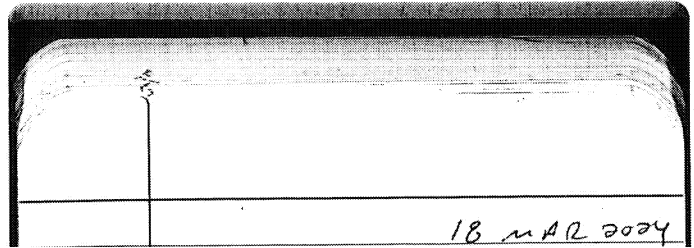

Um, so the next thing is just if I ask you something today and you don't know what I mean when I say the word, just tell me that, okay? Okay. So if I were to say something like, what is your ocular hue? What would you say to that?*

Zaria GRILLO-NEWTON *I don't know. Right?*

DC Woodley *Because you don't know. So if I were, instead to say, what's your eye colour? <affirmative>. What is your eye colour? I'm not sure. You're not sure? Well, what's my eye colour?*

Zaria GRILLO-NEWTON *Green.*

DC Woodley *Green. That's right. Well, my eye colour is actually blue, but maybe it looks green in the light, do you think? A little bit. A little bit? Yeah. So that's just me saying, you telling me that you don't know what I mean, and I'll ask it in a different way, so, you know. Okay. Okay. Okay. And sometimes I make mistakes like everybody does, right? Everybody makes mistakes and I might say something wrong. So when I do, can you just tell me that I'm saying that wrong? Okay. So if I were to say Zaria, you're 30 years old,*

Zaria GRILLO-NEWTON *I'm not 30 years old.*

DC Woodley *That's right. You would say you're wrong. I'm not 30. 'cause how old are you? Five. That's a huge difference, isn't it? Yeah. You're not 30. Okay. And as we go along, I don't know, um, what's happened or what's gone on. So I can't answer the question for you. Okay? Okay. Is you, you're just here to tell me what happened. I can't answer that. Okay? Okay. And the last thing is that it's just really important that you tell me the truth today, okay? Okay. So do you tell promise to tell me the truth? Yeah. Will you tell me any lies? Okay. So Zaria, let's just talk first about you and what are some things that you really like to do?*

Zaria GRILLO-NEWTON *Um, eat watermelon.*

DC Woodley *Eat watermelon. What is it about watermelon that you like?*

Zaria GRILLO-NEWTON *I like the texture.*

DC Woodley *You like the texture?*

Zaria GRILLO-NEWTON *Yeah.*

DC Woodley *Yeah? Yeah. What else do you like about it?*

Zaria GRILLO-NEWTON *I like the flavour.*

DC Woodley *The flavour. It's very sweet, isn't it? Yeah.*

Zaria GRILLO-NEWTON *And I also like that colour.*

DC Woodley *What colour would you call watermelon? Red. Red. Do you have a favourite colour?*

Zaria GRILLO-NEWTON *Pink. Pink And purple.*

DC Woodley *And purple.*

Zaria GRILLO-NEWTON *And*

DC Woodley *Red. And red. Well,*

Zaria GRILLO-NEWTON *That's good. And*

DC Woodley *Yellow?*

Zaria GRILLO-NEWTON *Light blue.*

DC Woodley *Light blue. Not dark light. Okay, well that's like almost all the colours in a rainbow, isn't it?*

Zaria GRILLO-NEWTON *Yeah.*

DC Woodley *What are some other things that you like to do?*

Zaria GRILLO-NEWTON *Um, play with mama.*

DC Woodley *You like to play with your mom, you can help if you want. Um, what do you guys like to play?*

Zaria GRILLO-NEWTON *I don't know what we like to play. It's just so much fun. Is*

DC Woodley *It*

Zaria GRILLO-NEWTON *Inside of my mouth is green?*

DC Woodley *It is. Maybe she just had like a green sucker and it turned her mouth green.*

Zaria GRILLO-NEWTON *Uh, maybe she had green shirt.*

DC Woodley *Oh, green sugar. That would turn your mouth green too. Okay. Well that's great. Thanks for sharing some of the things that you do. Like what about some things that you don't like? Can you tell me about those? What are things you don't like?*

Zaria GRILLO-NEWTON *Um, I don't like black.*

DC Woodley *You don't like the colour black? No. Hmm. Okay. What other things don't you like? Like is there any food you don't like?*

Zaria GRILLO-NEWTON *I don't like potatoes.*

DC Woodley *No potatoes, eh? Yeah. Nope. Anything else? Sometimes*

Zaria GRILLO-NEWTON *I like squash.*

DC Woodley *Do you with?*

Zaria GRILLO-NEWTON *With brown sugar.*

DC Woodley *Squash with brown sugar? Just sweeten it up a bit, eh? Yeah.*

Zaria GRILLO-NEWTON *Sweetened sweet and sweet and*

DC Woodley *Sweet. Um, anything else? What other things don't you like?*

Zaria GRILLO-NEWTON *Um, pointy.*

DC Woodley *Pointy. What do you mean by that?*

Zaria GRILLO-NEWTON *Like something that's really pointy that would poke into your skin.*

DC Woodley *Oh, right. I wouldn't like that either. Something sharp and pokey. Yeah. When was your last birthday? So you're five. So when did you turn five? Do you know? June 1st. June 1st. Okay. So just at the beginning, almost of summer. Yeah. And what did you do at your birthday?*

Zaria GRILLO-NEWTON *I invited everyone over. And also when I and everyone hit my pin.*

DC Woodley *You had a pinata. Tell me about that. Full*

Zaria GRILLO-NEWTON *Of trees and toys.*

DC Woodley *Wow. What else about the pinata? Can you tell me about?*

Zaria GRILLO-NEWTON *It was a unicorn.*

DC Woodley *It was a unicorn. I*

Zaria GRILLO-NEWTON *Love unicorns,*

DC Woodley *Right? What else? It's full of trees and it was a unicorn corn. So you guys hit the pinata and then what did you do after that at your party?*

Zaria GRILLO-NEWTON *And then we picked up all of the candy and ate it all. Yum, yum.*

DC Woodley *Yum. Yum, yum. And then what did you do?*

Zaria GRILLO-NEWTON *And I think everyone left*

DC Woodley *And everyone left after the party, I think. Yeah.*

Zaria GRILLO-NEWTON *Drawings are really pretty.*

DC Woodley *You like those drawings? Yeah.*

Zaria GRILLO-NEWTON *How did you do them?*

DC Woodley *Oh, well, I can't say I did them. They look like they're pictures. Someone took pictures of flowers and then put them on, um, frame. A frame, yeah. And then put them on the wall. So it's like a decoration,*

Zaria GRILLO-NEWTON *But, but that one, they painted that one.*

DC Woodley *It looks like a painting. It sure does.*

Zaria GRILLO-NEWTON *And then they put it on a metal frame. They did? Yeah.*

DC Woodley *So Zaria, where who do you live with?*

Zaria GRILLO-NEWTON *Mama.*

DC Woodley *Your mom? And who all lives there?*

Zaria GRILLO-NEWTON

DC Woodley *Okay. And who's*

Zaria GRILLO-NEWTON *He lives with us.*

DC Woodley *He lives with you? Okay. Um, do you have any animals at home?*

Zaria GRILLO-NEWTON *Um, we have a dog. You*

DC Woodley *Oh, okay. So do you live with ' or you live with mom and and then you*

Zaria GRILLO-NEWTON *I visit You visit,*

DC Woodley *You visit every day?*

Zaria GRILLO-NEWTON *Pretty much.*

DC Woodley *Oh wow. So you get to see the chickens and the cats every day? Yeah.*

Zaria GRILLO-NEWTON *That's*

DC Woodley *Fun. And is there anybody else in your family? No. So you have mom, ? Mm-hmm. <affirmative>. Do you have any brothers and sisters? No. Um,*

Zaria GRILLO-NEWTON *I'm kind of like my little sister.*

DC Woodley *You're like your little sister? Mm-hmm.*

Zaria GRILLO-NEWTON *<affirmative>? No, he is, he is my kind of my brother.*

DC Woodley *Who's that?*

Zaria GRILLO-NEWTON *Um, Milo.*

DC Woodley *Milo?*

Zaria GRILLO-NEWTON *He's my dog.*

DC Woodley *Oh, he's your dog. That's your dog's name. Milo. That's a great name. And so he's like your little brother. What do you like to do with Milo?*

Zaria GRILLO-NEWTON *Um, play.*

DC Woodley *Yeah.*

Zaria GRILLO-NEWTON *Sometimes likes playing.*

DC Woodley *Does he? Yeah. Okay. And who else is in your family?*

Zaria GRILLO-NEWTON *My chickens. Two chickens. You*

DC Woodley *Have two chickens and a dog you said?*

Zaria GRILLO-NEWTON *And*

DC Woodley *Cats. And cats, okay.*

Zaria GRILLO-NEWTON *Two cats.*

DC Woodley *Okay.*

Zaria GRILLO-NEWTON *Two cats and two chickens.*

DC Woodley *And so they, that's at house. and then*

Zaria GRILLO-NEWTON

DC Woodley *At your mom's house, you have a dog.*

Zaria GRILLO-NEWTON

DC Woodley *And then is there anywhere else that you go to visit with family?*

Zaria GRILLO-NEWTON *No. No? Sometimes we go to work.*

DC Woodley *Is your family or he's the one that lives with you?*

Zaria GRILLO-NEWTON *He's the one that lives with me.*

DC Woodley *Oh, okay.*

Zaria GRILLO-NEWTON *But*

DC Woodley *So what about your dad?*

Zaria GRILLO-NEWTON *I don't have a dad.*

DC Woodley *You don't have a dad? Okay. Do you ever, why do you say you don't have a dad?*

Zaria GRILLO-NEWTON *Because I don't have a dad.*

DC Woodley *No. You don't have a dad that you visit sometimes? No. So what if I say that I know you have a dad?*

Zaria GRILLO-NEWTON *I don't have*

DC Woodley *A dad. You don't have a dad. Do you know why you're here to talk with me today? Yeah. And why is that?*

Zaria GRILLO-NEWTON *'cause I need to tell some bad things.*

DC Woodley *Okay. Can you tell me what those bad things are? Yeah. What are they?*

Zaria GRILLO-NEWTON *That he put his pyramid on me.*

DC Woodley *Sorry.*

Zaria GRILLO-NEWTON *He put his pyramid on me.*

DC Woodley *His pyramid on you?*

Zaria GRILLO-NEWTON *His penis.*

DC Woodley *His penis? And who, who put your, his penis on you?*

Zaria GRILLO-NEWTON *My father.*

DC Woodley *Your father?*

Zaria GRILLO-NEWTON *And he tied me up.*

DC Woodley *And he tied you up?*

Zaria GRILLO-NEWTON *And he locked me in a room.*

DC Woodley *He locked you in a room with*

Zaria GRILLO-NEWTON *No food and drink.*

DC Woodley *Oh, okay. What's your dad's name?*

Zaria GRILLO-NEWTON *Newton.*

DC Woodley *Newton.*

Zaria GRILLO-NEWTON *It's not my dad.*

DC Woodley *No. No.*

Speaker 3 *Okay.*

DC Woodley *Can you tell me more about when he put his penis on you?*

Zaria GRILLO-NEWTON *I don't know what day it was.*

DC Woodley *Well, that's okay. You don't have to remember that. What day? And thank you for telling me you don't remember. What day, where were you*

Zaria GRILLO-NEWTON *In? In his room.*

DC Woodley *You're in his room. And where in his room?*

Zaria GRILLO-NEWTON *In this is, uh, um, on the floor.*

DC Woodley *You were on the floor in his room?*

Zaria GRILLO-NEWTON *When he locked me up.*

DC Woodley *He locked you up? Okay. So what was happening before he locked you up? In his room?*

Zaria GRILLO-NEWTON *There's also details.*

DC Woodley *Pardon?*

Zaria GRILLO-NEWTON *Details.*

DC Woodley *Details. What do you mean by details?*

Zaria GRILLO-NEWTON *Like little things of it.*

DC Woodley *Oh, okay. Okay. So you told me a couple of things, so we're just gonna go over each thing, okay? Okay. So you told me that he touched you with his penis, and that happened*

Zaria GRILLO-NEWTON *In his room? At his house.*

DC Woodley *At his house, okay. And what do you remember about that? What happened?*

Zaria GRILLO-NEWTON *It happened. Oh, so, um, he, he, he locked me in the room with no food and or drank.*

DC Woodley *Did that happen at the same time that he touched you with his penis? No. That was a different time?*

Speaker 3 *Yeah.*

DC Woodley *Okay.*

Zaria GRILLO-NEWTON *I remember that, that day.*

DC Woodley *So the time that he touched you with his penis?*

Speaker 3 *Yeah.*

DC Woodley *You were in his room at his house?*

Zaria GRILLO-NEWTON *Yeah. And*

DC Woodley *What, what happened? Tell me more about that.*

Zaria GRILLO-NEWTON *And, and when he locked me in the room, it, it was like a regular door, like a regular door.*

DC Woodley *Oh, okay. When he locked you in the room, it was a regular door. Okay. So when he touched you with his penis, um, what happened?*

Zaria GRILLO-NEWTON *Um, what happened? Um, so that was at nighttime?*

DC Woodley *It was at nighttime. And where were, you were in his room, but where on in his room?*

Zaria GRILLO-NEWTON *Um, on, on his bed. And then he, he was laying on top of me.*

DC Woodley *He was laying on top of you on his bed? Yeah. And then do you remember what happened?*

Speaker 3 *Uh,*

Zaria GRILLO-NEWTON *Uh, no. That's all I remember about that one. Okay. That's all the details. What colour fake skin should I do?*

DC Woodley *Um, you can do whatever colour you like.*

Zaria GRILLO-NEWTON *Maybe it should be yellow and red.*

DC Woodley *Okay.*

Zaria GRILLO-NEWTON *And I'm gonna go yellow. So*

DC Woodley *He was laying on top of you and he touched you with his penis. Where did he touch you with his penis?*

Zaria GRILLO-NEWTON *On the belly.*

DC Woodley *On the belly.*

Zaria GRILLO-NEWTON *I didn't make that fourth yellow. And*

DC Woodley *What were you wearing? Do you remember if you*

Zaria GRILLO-NEWTON *He wasn't wearing anything.*

DC Woodley *He wasn't wearing anything at the time?*

Zaria GRILLO-NEWTON *No, but I was,*

DC Woodley *You were wearing something.*

Zaria GRILLO-NEWTON *I was wearing jammies.*

DC Woodley *You had jammies on. Is there anything else that you remember about that?*

Zaria GRILLO-NEWTON *No. That's all I remember about that one.*

DC Woodley *Yeah. So you told me too, that he would lock you up.*

Zaria GRILLO-NEWTON *Yeah.*

DC Woodley *Can you tell me more about that?*

Zaria GRILLO-NEWTON *With no food and drink.*

DC Woodley *Where would he lock you?*

Zaria GRILLO-NEWTON *In his room.*

DC Woodley *In his room. And you didn't have food or drink?*

Zaria GRILLO-NEWTON *Right?*

DC Woodley *Do you remember when that happened? Sorry,*

Zaria GRILLO-NEWTON *I don't remember that. I remember the day.*

DC Woodley *You do remember the day?*

Zaria GRILLO-NEWTON *I don't.*

DC Woodley *You don't? Do you remember what happened, like before you were locked up? No.*

Zaria GRILLO-NEWTON *And he tied me up.*

DC Woodley *He tied you up? Where did he tie you up?*

Zaria GRILLO-NEWTON *On my hands.*

Speaker 3 *Okay.*

Zaria GRILLO-NEWTON *Arms, belly*

Speaker 3 *Back,*

DC Woodley *Tied you up on your hands, your arm, your belly and back. And what did, what did he use? Like what did it look like that he used to tie you up?*

Zaria GRILLO-NEWTON *It was like skinny.*

DC Woodley *It was skinny*

Zaria GRILLO-NEWTON *And green and brown.*

DC Woodley *Okay. And he tied you up. And then what did he do next?*

Zaria GRILLO-NEWTON *And then he went outside and I just followed him around.*

DC Woodley *He went outside. Outside where?*

Zaria GRILLO-NEWTON *Outside. Just on the porch.*

DC Woodley *On the porch. And you said you followed him.*

Zaria GRILLO-NEWTON *Are those pretend real?*

DC Woodley *Yeah, they're not real. So you wanna just turn around Zaria we're not done or colouring. Okay. We can just keep colouring here. So you followed him outside? Yeah.*

Zaria GRILLO-NEWTON *Um, onto the porch.*

DC Woodley *Were you still tied up?*

Zaria GRILLO-NEWTON *Yeah. And I used my teeth to get out.*

DC Woodley *You used your teeth to get out like that? Okay. Was anybody else at the house? No. No? And you said that he locked you in the room too?*

Speaker 3 *Mm-hmm.*

Zaria GRILLO-NEWTON *<affirmative>. Oh, really? Colourful.*

DC Woodley *Yeah. So tell me more about that.*

Zaria GRILLO-NEWTON *More about what?*

DC Woodley *When he locked you in the room.*

Zaria GRILLO-NEWTON *He didn't gimme any food or drink. And he locked me in with a, with a key?*

DC Woodley *With a key. How do you know it was a key?*

Zaria GRILLO-NEWTON *Because he showed me the key.*

DC Woodley *He showed you the key? Yeah. And what was, what happened right before that, before he locked you up?*

Zaria GRILLO-NEWTON *I don't remember.*

DC Woodley *You don't remember? Do you remember how long you were locked up for?*

Zaria GRILLO-NEWTON *For the whole day.*

DC Woodley *The whole day. And what happened that day? Then tell me about that day*

Zaria GRILLO-NEWTON *And then, and then the next day, day. Um, and then the next day he let me out.*

DC Woodley *The next day he let you out. Did he say anything to you?*

Zaria GRILLO-NEWTON *No.*

DC Woodley *No? What did you do when you were in the room?*

Zaria GRILLO-NEWTON *Um, didn't give me any toys. He*

DC Woodley *Didn't give you any toys? So what did you do?*

Zaria GRILLO-NEWTON *So I just walked around and, and that's all I did.*

DC Woodley *You just walked around? What's in the room?*

Zaria GRILLO-NEWTON *No toys.*

DC Woodley *No toys. Do you remember anything else about that day?*

Zaria GRILLO-NEWTON *No.*

DC Woodley *No? And then you said the next day he let you out. Yeah. And then what did you guys do together the next day?*

Zaria GRILLO-NEWTON *Hmm. I don't remember what we did the next day.*

DC Woodley *You don't remember*

Zaria GRILLO-NEWTON *Bump this off? We kind of see the princess from the back.*

DC Woodley *You can? Yeah. It goes through the back. You can see the printout, can't you?*

Zaria GRILLO-NEWTON *Yeah.*

DC Woodley *Have you told anybody else about these things that have happened?*

Zaria GRILLO-NEWTON *No.*

DC Woodley *You haven't told anyone else?*

Zaria GRILLO-NEWTON *I think they should be red and plus I already started colouring it red.*

DC Woodley *Yeah. Finish it in the red colour?*

Speaker 3 *Yeah.*

DC Woodley *So you haven't told anybody else about the bad things that have been happening?*

Zaria GRILLO-NEWTON *Maybe one more police officer you told me and I don't remember the name. Oh,*

DC Woodley *Okay.*

Zaria GRILLO-NEWTON *They, I don't think they even told us the name.*

DC Woodley *No. Have you talked to any family about this?*

Zaria GRILLO-NEWTON *I think maybe mama. Yeah, I think mama.*

DC Woodley *Okay. Do you remember when these things happened?*

Zaria GRILLO-NEWTON *No. I don't remember the days. Okay. And he also put gummy bears in my bum.*

DC Woodley *He put gummy bears in your bum. Can you tell me more about that?*

Zaria GRILLO-NEWTON *Okay. Um, this, there's a couple details about that to,*

DC Woodley *Okay. And,*

Zaria GRILLO-NEWTON *And we used the spatula to, to push it in.*

DC Woodley *Use the spatula To push what? In?*

Zaria GRILLO-NEWTON *To push the gummy bear in.*

Speaker 3 *Okay.*

DC Woodley *So tell me more about that. What you remember, what happened?*

Zaria GRILLO-NEWTON *So the gummy bear, and he also made me, make me taste one.*

DC Woodley *He made you taste a gummy bear. And where did that happen?*

Zaria GRILLO-NEWTON *In his room, on my belly.*

DC Woodley *In his room? On your belly,*

Zaria GRILLO-NEWTON *On his bed.*

DC Woodley *On his bed? Yeah.*

Zaria GRILLO-NEWTON *Above his bed.*

DC Woodley *Get the, the crayon. So the day that he put the gummy bear in your bum, can you tell me about that day?*

Zaria GRILLO-NEWTON *I don't remember. Just the day.*

DC Woodley *You don't remember the day? Well, how about you just tell me everything you remember about when you were on the bed,*

Zaria GRILLO-NEWTON *Okay. Okay. And he used a spatula to push it. And then we, and then I put my clothes back off.*

DC Woodley *Okay. So you had your clothes off?*

Zaria GRILLO-NEWTON *I just pulled them down.*

DC Woodley *You pulled what? Down?*

Zaria GRILLO-NEWTON *My pants.*

DC Woodley *Your pants down. I'm*

Zaria GRILLO-NEWTON *Going to do this one green.*

DC Woodley *Okay. How about I do the red. You do the green? So you pulled your pants down and then what happened?*

Zaria GRILLO-NEWTON *And then, um, then that, and then I pulled my pants back up When he was done.*

DC Woodley *When he was done what?*

Zaria GRILLO-NEWTON *When he was done with the one thing.*

DC Woodley *And what one thing was that?*

Zaria GRILLO-NEWTON *When he was done pushing the dummy bear. And*

DC Woodley *Where did he push the gummy bear?*

Zaria GRILLO-NEWTON *In? My bum.*

DC Woodley *In your bum. And what happened after that? He pushed the gummy bear in your bum. And then what happened?*

Zaria GRILLO-NEWTON *I do that and then, and then, and then I pulled my pants up.*

DC Woodley *Oh, okay.*

Zaria GRILLO-NEWTON *Wait, that one's green.*

DC Woodley *I did, I mixed it up, didn't I? That's*

Zaria GRILLO-NEWTON *Okay. That*

DC Woodley *Is okay. We all make mistakes.*

Zaria GRILLO-NEWTON *They can be a double green.*

DC Woodley *Okay. What, uh, you pulled up your pants and then what happened? And,*

Zaria GRILLO-NEWTON *And then I just followed him around.*

DC Woodley *You followed him around where?*

Zaria GRILLO-NEWTON *Outside.*

DC Woodley *Outside. Was there anybody else there?*

Speaker 3 *No.*

DC Woodley *No?*

Zaria GRILLO-NEWTON *What else should I do? Green. You*

DC Woodley *Can do these ones green if you like. Okay. So the gummy bear, do you remember when that happened?*

Zaria GRILLO-NEWTON *No. I don't remember that day.*

DC Woodley *No.*

Zaria GRILLO-NEWTON *Hey, we still have all these ones to do.*

DC Woodley *We do. We have a lot there. So you said you turned, your birthday was June and you turned five. So would've it have happened before or after your birthday? Do you know?*

Speaker 3 *No.*

DC Woodley *No? Okay. So you told me about the gummy bear. You told me about him*

Zaria GRILLO-NEWTON *Tying me*

DC Woodley *Up, tying you up. You told me about*

Zaria GRILLO-NEWTON *Gummy bear.*

DC Woodley *The gummy bear*

Zaria GRILLO-NEWTON *Walking in the room.*

DC Woodley *Yeah. Locking you in the room. And about him touching you with his penis. Did these things all happen around the same time? No.*

Zaria GRILLO-NEWTON *Not on the same*

DC Woodley *Day. Not on the same day. Okay. Are there any other things that you wanna tell me about?*

Zaria GRILLO-NEWTON *No.*

DC Woodley *No?*

Zaria GRILLO-NEWTON *Well, maybe there is.*

DC Woodley *Okay,*

Zaria GRILLO-NEWTON *Let me just think for a minute. Sure. Anyways, what? This princess is looking good. Mm-hmm.*

DC Woodley *<affirmative> good.*

Zaria GRILLO-NEWTON *We are saying there's no blue.*

DC Woodley *No. We can add in blue if you want.*

Zaria GRILLO-NEWTON *Yeah. Let's add some blue. Now I'm gonna do some more of these things. Blue.*

DC Woodley *Okay.*

Zaria GRILLO-NEWTON *Fix this.*

DC Woodley *So, sorry. When the gummy bear happened, how, how did you feel about that?*

Zaria GRILLO-NEWTON *I didn't like it. No.*

DC Woodley *Okay.*

Zaria GRILLO-NEWTON *I said no to every one of them. And he still did it.*

DC Woodley *You said no to every one of them.*

Zaria GRILLO-NEWTON *And he still did it.*

DC Woodley *Did he do more than one?*

On Wednesday September 27th, 2023 the victim Zaria GRILLO-NEWTON attended the Norfolk County detachment where she provided a video and audio statement to Detective Constable Jerusha WOODLEY. Child and Family Services of Grand Erie employee, _____ was present and observed the statement as well as D/Sgt. Wilfong and DC Andrew Beck. The statement began at 10:51 a.m., and concluded at 11:46 a.m. (See attached synopsis for details)

Throughout the statement Zaria GRILLO-NEWTON was articulate and was able to described four (4) separate incidents in detail but lacked any specific surrounding the incidents. All of the alleged incidents were described as taking place at Adam NEWTON's residence located at 34 Somerset Drive Norfolk County, Ontario.

At the conclusion of the statement it was decided that D/S/Sgt. Haltse would be consulted and provided the opportunity to review statement which assist the direction of the investigation.

Further, DC Andrew Beck contacted Adam NEWTON and offered him an opportunity to provide a statement to the police. Adam NEWTON declined the invitation on the advice of his lawyer.

- Her buttock is so inflamed and red when she comes home. The doctor describes it as lesions
- She doesn't get this when she is in her care

Following the interviews with Melanie and Zaria, Melanie shared an audio recording made on August 22, 2022 between her, Zaria and . Melanie was advised her not to send Zaria for visitation with her father until the investigation was completed and until a safety plan could be put into place.
