Narrative Brianna Boyd On 14/09/2022 09:29 Interview with Zaria Grillo-Newton Private Interview with Child 2:05pm – After Zaria's access visit with dad I interviewed her privately at the Society office in Townsend. After she hugged her dad and said goodbye, I met with Zaria in the access room. I asked her to tell me about her visit with dad and she said it went good. I asked if there was anything she really liked about her visit today and she said she liked playing with the flinging chickens. I asked what things she liked to do at dads house and she said she liked to play with [REDACTED] there. I asked if there was anything she did not like and she laughed and shrugged. I asked her if there was anything different about today's visit then when she usually sees dad and she would not answer. She wanted to play house and kept pretending to cook me various things on the play stove top. When I asked if she could tell me about what she does at dads house usually she would not say anything. She walked away and would not answer. When I asked her about moms house she would talk about doing school there and about what she was learning. She talked about doing crafts at home with mom. I asked if there was anything she did not like to do at home with mom and she laughed and said no. I asked her if she wanted to talk about dads house and she again would not answer. She was very distracted playing with toys in the access room and stopped answering all questions about dad. I asked if she wanted to go upstairs and talk in a different room and she said yes. She brought her chicken with her that dad gave her. Upstairs we sat in another interview room and she again wanted to play around the room. Again we started talking about mom and she talked happily about doing crafts at home, visits [REDACTED] and talked about her cats. When I asked about dads house she ran behind a chair and hid from me and would not talk. I asked her if she could show me with her chicken and act out what happens when she and dad watch and movie at his home. She laughed and sat the chicken on a chair and said they were watching a movie. I asked what else happens when she is at dads and she pointed to the chicken's buttocks under it's tail. I asked her to tell me about this and she said, "we play the flower game" and I asked what the flower game was and she said there is rings to set up but said nothing more and then proceeded to run and hide again in the room. She started running up and trying to kiss me. I told her that we do not kiss and asked her to please sit down. She made two more attempts trying to kiss me and each time I redirected and said we do not kiss and she ran away again. I asked if there was anything else she wanted to talk about and she just said she wanted mom so I agreed and we began walking to the parking lot together. She ran happily up to mom and they hugged before she got into the car. Interview with Melanie: After meeting with Zaria I met with Melanie briefly. She provided me full unrestricted verbal consent to speak with [REDACTED] She indicated that it was hard to see Zaria go in there today. I let her know the visit went well and she did great and they appeared to have fun. She asked about next steps and what needed to be done and I explained that she can always speak to her lawyer about what to do, but for right now we will be building on dads access to give Zaria more time with him in a more comfortable setting like his home but still with full supervision from us or others that may be suggested.
