"On September 14, 2023 information was received from Esther Herschberger, who is a Therapist at Thrive. Esther advised that she is seeing Zaria Grillo-Newton for therapy and has been since July 2023.

Esther advised that on August 25th Zaria attended an appointment with Esther and was "hyperventilating and crying" for about 30 minutes as she was going to be having an access visit with her dad that weekend. Zaria told Esther that she didn't want to go to dad's as she didn't want to get tied up again. There was a stick figure in the office and Zaria showed Esther rope being tied from the stick figures shoulders to waist and around the stick figures waist, Zaria said that's how she was tied up. She told Esther she didn't want to sleep naked with dad or see his penis. I clarified the use of the word penis as previously Zaria would not use this word, and Esther confirmed that she has spoken to Zaria in a previous session about using anatomically correct words.

Esther advised that Zaria was hyper ventilating as a result of going for a visit with dad as the court order had changed recently from access at a park (supervised) to dad's home (supervised). As such Zaria was upset and this is when she indicated all the things she was worried about going to dad's house for access.

Parents are engaged in CLRA matter and both have legal counsel

The Society has previously investigated the sexual abuse allegations. The Society verified the concerns however, this was reviewed by an internal panel and the verification was then determined to be not conclusive.

Zaria has provided new information regarding the sexual abuse (being tied up) as such a new investigation is going to be initiated.
